- 1. <u>Purpose</u>. To implement Secretary of the Navy approval to establish subject shore activity and Chief of Naval Operations (CNO) approval of disestablishment of subject detachment per reference (a).
- 2. <u>Background</u>. Action results from a recent CNO decision increasing the Base Operating Support funding level at Naval Postgraduate School (NPS). Establishment of the command on site at Monterey will enhance the ability of Commander, Navy Installations Command to meet NPS installation support requirements. Manpower to establish the command will come from existing detachment on site.
