1. Purpose. To implement Secretary of the Navy approval to establish subject shore activity per reference (a).

2. Background. This action establishes U.S. Aegis Ashore Missile Defense System Romania in accordance with the U.S. and Romanian Ballistic Missile Defense Agreement signed in September 2011. The activity will be part of the European Phased Adaptive Approach to missile defense. Host Nation Notification is not required for this action as it was publically announced by the two governments last year.
