

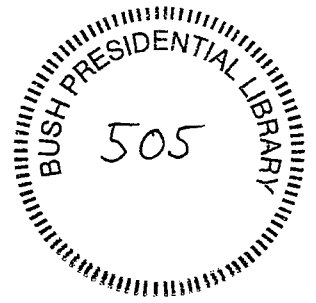

SUBJECT: U.S. Policy Toward South Asia (Ø)

The changing situation in Afghanistan and our continuing stake in South Asian stability require that we undertake a comprehensive review of U.S. policy toward South Asia, with a principal focus upon U.S. relations with India and Pakistan. (Ø)

The review should be completed not later than March 24, 1989. It should include clear policy options/recommendations. Any differences in views between agencies should be noted. At a minimum, the review should address the following questions and issues:

PART I: ASSESSMENT

- What are the prospects for internal stability within India and Pakistan? Similarly, what are the prospects for democracy and economic growth? (Ø)
- What are U.S. interests in South Asia? How does the Soviet withdrawal from Afghanistan affect these, especially in Pakistan? (Ø)
- What can be anticipated from India in terms of its regional diplomacy? | (b)(1) \_\_\_\_\_
- How do we expect Pakistan to view its relationship with the United States in the post-Zia era and in the wake of the withdrawal of Soviet troops from Afghanistan? | (b)(1) \_\_\_\_\_
